- You will not be required to file an application for exemption on this property in future years providing you own it on July 1 of each year and are a resident of Iowa.
- Fill in all areas. Note: The Assessor's Office can fill in the LEGAL DESCRIPTION if you do not know it.
- Print application, sign, and date and mail to above address. *This application cannot be electronically submitted in any way.*
