Letter From The Director

As I sat down to write this message, I thought of how previous years had been punctuated by some sort of emergency or disaster. I was just about to celebrate a year free of major disasters when I remembered the flooding this Spring. How could I have forgotten that?! I have two justifications for my lapse in memory. The first is that our bar for declaring an event to be unusual has been set quite high. The second is that since we have participated in emergency response and recovery events before and have learned many lessons from our experiences. We were much better prepared for our role in these events and, while still disruptive of normal routines, we take them in stride. The new reality seems to be that we will be involved in more frequent emergencies or unusual events and that integrating with our other response and community partners is the norm.

Unfortunate as that may sound, it has yielded benefits. As we strive to understand and find our place among the changes coming in the health care system, we find the same expectations there as we have in the realm of emergency response. We cannot function to provide the best health outcomes for the population unless there is a tangible sense of cooperation and that we're all playing on the same team. While this can be uncomfortable and may not be the model that has been used in the past, it is the reality of the future. We are fortunate to be in a community which, in many aspects, is well ahead of the curve.

Internally at JCPH, we have been working on a strategic plan to ensure that we develop a culture of quality improvement. This may require adjustments as we examine how we interact not only with our external partners, but how we work internally as a team to improve our services. The plan is due to be finished by the end of 2013 and promises to be challenging and exciting. As always, I consider myself fortunate to be associated with so many talented and dedicated individuals. I look forward to being a part of this county's efforts to improved health and protection of the environment.

WIC/MCH DIVISION

The WIC/Maternal and Child Health (MCH) division advocates for and serves high-risk low-income families. Services available include the Special Supplemental Nutrition Program for Women, Infants and Children (WIC), breastfeeding peer counseling, Child Health, Maternal Health, immunizations, the I-Smile Oral Health Program, Head Start nursing services, obtaining medical insurance, and establishing medical/dental homes. Multiple counties are served based upon the service area designations from the Iowa Department of Public Health. Programs are focused on provision of or access to preventive health services. High-risk families are assisted with locating and accessing health services based upon individual family resources and program eligibility. Successfully accessing these services promotes overall health and stability within the family. Healthy families contribute to a positive and thriving community.





ADMINISTRATION DIVISION

Administration provides customer service, general reception to the public, and supports the Board of Health through general support activities. Administration is responsible for fiscal management, personnel functions and coordinates grant fund processing. Because Johnson County Public Health often collaborates with other agencies, funding from various grant sources requires administrative processes including tracking grant related correspondence, fiscal transactions and archiving appropriate fiscal documents. The Administrative Division is fully responsible for the Local Public Health Services Contract that provides funds for Disease Outbreak Investigations, Health Hazards Investigations, Community Needs Assessment, Public Health Nursing, Home Care Aide and Modernization.

Community Health

Community Health programs create an environment that assists people in making healthy choices where they live, learn, work and play. Through promotion, education and regulation we strive to prevent diseases and promote health.

Emergency Preparedness

Emergency Preparedness program activities focus on improving public health response capabilities and communication systems in order to plan for, respond to and recover from public health emergencies in Johnson County.

Communicable Disease (CD)

CD Follow-Up is a county responsibility per Iowa Code. The program investigates cases of infectious diseases and institutes prevention measures to limit the spread of disease. FY2013 was a busy year due to a pertussis outbreak

Community Environmental Protection consists of the Tanning, Tattoo, Swimming Pool/Spa, Hotel/Motel and Environmental Health Nuisance programs. These are contractual programs in which the authority to enforce the applicable Iowa Code chapters has been delegated to Johnson County Public Health by the Iowa Department of Public Health. Facilities are inspected to determine compliance with the regulations set forth in the Iowa Code in an effort to ensure the health and safety of the public.

Radon

Radon is a colorless, odorless, naturally-occurring radioactive gas that poses a health threat when sufficient concentrations occur in enclosed areas such as basements. Iowa has the largest percentage (71.6%) of homes above the US Environmental Protection Agency action level of 4pCi/L, in the US. Johnson County Public Health began offering radon test kits for sale to the public at cost in 2011. Sales of radon test kits have increased each year. The test kits cost just \$5 and are available to pick up in person or by mail.

ENVIRONMENTAL HEALTH

Johnson County Environmental Health programs seek to prevent or control the spread of infectious disease and to protect our environment through regulation, education, case follow-up activities, and consultation. Program activities primarily fall under three categories, Watershed Protection, Food Protection and Community Environmental Protection.

Watershed Protection consists of the Private Water Well, Transient Non-Community Well, Grants-to-Counties and Onsite Wastewater programs. These programs focus on protecting surface and groundwater supplies from contamination through permitting, inspections and the enforcement of Iowa DNR regulations.

Health Promotion

Health Promotion programs promote health behaviors, advocate for environments that support health, and provide a wide variety of community-based health promotion services. Services provided in FY2013 include: planning, implementing and evaluating educational events for those at risk for acquiring HIV; providing HIV and hepatitis C counseling, testing and referral services; tobacco use prevention and control; providing an Employee Wellness Program for Johnson County employees; and implementing health promotion programs and coalitions, such as the Alliance for Healthy Living.

Tobacco Grant

Johnson County Public Health works with community partners to prevent the initiation of tobacco use by youth, reduce exposure to secondhand smoke, and promote tobacco cessation. Main objectives include creating youth groups that focus on tobacco prevention, encouraging business owners to adopt smoke-free and tobacco-free policies for their properties, and promoting the free cessation hotline (Quitline Iowa). Community coalitions that address tobacco use are currently active in Johnson, Iowa, and Poweshiek counties.

Community Transformation Grant (CTG)

The Community Transformation Grant (CTG) is wrapping up year two of the five year project. Over the course of the year, CTG received a mini-grant to plan and implement Walking School Bus programs with Horn and Twain Elementary Schools; worked with businesses to assess Worksite Wellness Programs and vending machines; completed walkability and bikeability assessments in Tiffin, North Liberty and will be working with Solon in FY14 to determine strengths and opportunities to improve walkability and bikeability.

Mpowerment FY '13 FY '12

Mpowerment Iowa City (MPowerIC) is Johnson County's community based group for young gay and bisexual men dedicated to creating an educated, empowered, and supportive community with a focus on sexual responsibility and risk reduction.
