WORKING GROUPS 2021

The council's working groups meet to research, organize, & draft recommendations on the following topics.

INFRASTRUCTURE FOOD PROCESSING & STORAGE

Throughout 2021, members gathered input from stakeholders to better understand local food infrastructure needs in Johnson County. This input was collected through interviews, surveys, a Local Food Storage and Processing Roundtable event, and three tours of local kitchens and processing facilities (1105 Project Kitchen, Old Brick, Open Gates Group). The group has found that our community is full of value-added entrepreneurs who are excited about processing and selling their products. While there are several great resources available for local food processing, more space is needed to support the number of current and aspiring value-added business owners. Through our network, we have learned that a few community organizations are planning to build additional processing space in the near future. Stay tuned for updates on these new spaces!

EQUIPMENT SHARING REDUCING GROWER BARRIERS

Members supported the development of Iowa Valley RC&D's Equipment Share Program by reaching out to stakeholders to ask about needs, providing feedback, and writing a letter of support to present to the Board of Supervisors.

MARKETING SPREADING THE WORD

This group helped plan the public forum, including the forum theme, guest speakers, and marketing plan. Members learned how to navigate hosting an online forum and providing translation services.



FOOD JUSTICE COMMITMENT TO EQUITY

Members worked to build connections with local organizations committed to racial and social justice to better understand their needs and priorities, identify where their work intersects with the council's work, and discuss how the council can work in partnership with them. This group also facilitated Food Justice discussions at council meetings which helped build a habit among council members of prioritizing equity in all conversations and decisions made about food system issues.

\$200,000 ALLOCATED TO LOCAL FOOD!

The Board of Supervisors allocated S200,000 of American Rescue Plan Act funds to support local food initiatives and increase access to healthy, local options over the next three fiscal years.
