CONSTRUCTION EVALUATION RESOLUTION

WHEREAS, Iowa Code section 459.304(3) sets out the procedure if a board of supervisors wishes to adopt a “construction evaluation resolution” relating to the construction of a confinement feeding operation structure; and

WHEREAS, only counties that have adopted a construction evaluation resolution can submit to the Department of Natural Resources (DNR) an adopted recommendation to approve or disapprove a construction permit application regarding a proposed confinement feeding operation structure; and

WHEREAS, only counties that have adopted a construction evaluation resolution and submitted an adopted recommendation may contest the DNR’s decision regarding a specific application; and

WHEREAS, by adopting a construction evaluation resolution the board of supervisors agrees to evaluate every construction permit application for a proposed confinement feeding operation structure received by the board of supervisors between February 1, 2022 and January 31, 2023 and submit an adopted recommendation regarding that application to the DNR; and

WHEREAS, the board of supervisors must conduct an evaluation of every construction permit application using the master matrix created in Iowa Code section 459.305, but the board’s recommendation to the DNR may be based on the final score on the master matrix or may be based on reasons other than the final score on the master matrix.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF JOHNSON COUNTY that the Board of Supervisors hereby adopts this construction evaluation resolution pursuant to Iowa Code section 459.304(3).

RESOLUTION NO. 01-06-22-01

RESOLUTION CONFIRMING SCHEDULE OF ZONING VIOLATION ABATEMENT ASSESSMENT

WHEREAS, on November 6, 2020, Johnson County, Iowa filed a county infraction citation for construction of an unpermitted structure on property located at 4398 Cosgove Road SW, Oxford, Johnson County, Iowa in violation of Chapter 8:6 of the Johnson County Unified Development Ordinance and §R105.1 of the International Residential Building Code; and

WHEREAS the property located at 4398 Cosgove Road SW, Oxford, Johnson County, Iowa is located in the unincorporated area of Johnson County and the property is owned by Mildred Roe Graham and Edward Charles Seydel; and

WHEREAS, on April 19, 2021 the Johnson County Magistrate Court ordered the property owners to obtain a building permit or remove the unpermitted structure by June 1, 2021; and

WHEREAS, on June 26, 2021 the Johnson County District Court upheld the ruling on appeal and ordered the property owners to obtain a building permit or remove the unpermitted structure by August 23, 2021; and

WHEREAS, both the Johnson County Magistrate Court and the Johnson County District Court ordered that if the property owners failed to obtain a building permit or remove the structure by a date certain that the County was authorized to abate or correct the violation and assess any costs for abatement against the property in the same manner as a property tax; and

WHEREAS, the Johnson County Planning, Development, and Sustainability (PDS) Department solicited multiple bids to perform the abatement and contracted with GLP Enterprises, Inc. to remove the unpermitted structure; and

WHEREAS, on September 16, 2021 the property owners had failed to obtain a building permit, PDS staff found that the unpermitted structure had not been removed, and the deadline imposed by the Court had passed; and

WHEREAS, on September 16, 2021 GLP Enterprises, Inc. performed the work necessary to abate and correct the violation and removed the unpermitted structure at a cost of \$6,500. The invoice from GLP Enterprises, Inc. was paid for said work on October 7, 2021; and

WHEREAS, Iowa Code §331.384 describes the process to assess the County's cost of abatement of the violation against the property for collection in the same manner as property tax; and

WHEREAS, following notice to the respective property owner and subsequent failure of the property owner to abate the violation as ordered by the Court, the County has expended public funds to abate the violation on the property; and

WHEREAS, the Planning, Development and Sustainability Department has filed with the Auditor the attached Johnson County Abatement Assessment Schedule showing the parcel where the violation was abated at public expense, a description of the lot to be assessed for such abatement, the value of the lot, and the amount to be assessed against the lot.

THEREFORE BE IT RESOLVED by the Board of Supervisors of Johnson County, Iowa;

The valuation of the lot described on the attached Johnson County Abatement Assessment Schedule (the Schedule) is hereby fixed at the amount shown for that lot in the "Property Value" column of the Schedule.

The Schedule is hereby adopted by this Board and declared to be final and received and filed as such.

The assessment against the lot as shown in the "Assessment Amount" column of the Schedule with respect to that lot is hereby confirmed and levied. The deficiency which may be subsequently assessed against each lot under Iowa Code §384.63 is hereby conditionally levied, subject to application of and compliance with Iowa Code §384.63, in the amount, if any, shown in the "Deficiency" column of the Schedule with respect to this lot.

Assessments less than five hundred dollars (\$500) shall be paid in full. Each assessment of five hundred dollars or more shall be divided into and is payable in ten (10) equal annual installments payable in accordance with Iowa Code §384.65. Interest on all unpaid installments shall accrue and be payable, in accordance with Iowa Code §384.65, at a rate of nine percent (9%) unless on the date of adoption of this Resolution a lower rate is in effect pursuant to Iowa Code §§74A.4 and 74A.6(2), in which event the lower rate shall apply.

The Assessment shown on the Schedule shall be payable by July 1, 2022. Installments into which an assessment is divided shall be payable July 1 of each year commencing in 2022.

The County Auditor as Clerk to this Board shall certify the Schedule of assessments to the Johnson County Treasurer for collection in the same manner as property taxes. The Auditor shall further cause notice of the Schedule to be published once each week for two consecutive weeks in a newspaper having general circulation in the County, the first such publication to be within fifteen (15) days of the adoption of this Resolution. The notice shall be in substantially the form attached to this Resolution as Exhibit A. On or before the second publication of the notice, the Auditor shall send by certified mail to the property owner whose property is subject to assessment for the abatement, as shown by the records in the office of the Auditor, a copy of the notice setting forth the information required by Iowa Code §384.60(2).

Payments received by the Treasurer shall be credited to the County's PDS fund, from which the abatement costs were originally appropriated.

Delinquent installments will draw the same delinquent interest as ordinary taxes. Property owners may elect to pay any installment semi-annually in advance. A person having an interest in any property specially assessed may appeal from the amount of the assessment, at any stage of the special assessment procedure up to twenty (20) days after the final publication of notice of filing of the final assessment schedule, by petition to the district court of the county where the property is located. No action shall be brought appealing the amount of any special

**RESOLUTION APPROVING APPLICATION UR-21-30592 FOR URBAN REVITALIZATION
TAX EXEMPTION FOR PROPERTY WITHIN THE NAPLES AVENUE URBAN

WHEREAS, Chapter 404, Code of Iowa provides for partial exemption from property tax for the actual value added by improvements to property located in a designated Urban Revitalization Area which are consistent with the Urban Revitalization Plan for such area; and

WHEREAS, the Board of Supervisors of Johnson County, Iowa adopted the Naples Avenue Area Urban Revitalization Plan via Resolution 12-21-21-02 and established the Naples Avenue Area Urban Revitalization District via Ordinance 12-22-21-02; and

WHEREAS, Rantizo, Inc. has filed application UR-21-30592 for Urban Revitalization Tax Exemption for improvements made at property legally described as Lot 3 of Scott's Second Addition ("Application UR-21-30592"), which is wholly within the Naples Avenue Area Urban Revitalization District; and

WHEREAS, the applicant received prior approval of eligibility for a tax exemption from the Board of Supervisors of Johnson County, Iowa via resolution 3-18-21-02 where it was resolved to approve the local match policy requirement of the Iowa Economic Development Authority and approve a local match utilizing a 100% tax abatement on the increase in assessed value over a 3-year period; and

WHEREAS, the application and all improvements are consistent with Chapter 404, Code of Iowa, the Naples Avenue Urban Revitalization Plan and all applicable county codes and ordinances; and

WHEREAS, Application UR-21-30592 has been received, reviewed and recommended for approval by the Planning, Development, and Sustainability Department and the County Assessor's Office.

NOW, THEREFORE, BE IT RESOLVED By the Board of Supervisors of Johnson County, Iowa that Application UR-21-30592 is found to be in compliance with the purpose and intent of Chapter 404 of the Code of Iowa and the Naples Avenue Urban Revitalization Plan; and

BE IT FURTHER RESOLVED that the tax exemption of one hundred percent (100%) of that portion of actual value added by the improvements described in Application UR-21-30592, as determined by the County Assessor, is hereby approved for a period of three (3) years, provided such improvements actually made increase the assessed valuation of the qualified real estate by at least fifteen percent (15%).

RESOLUTION APPROVING THE 2022 JOHNSON COUNTY, IOWA, ECONOMIC DEVELOPMENT PLAN: OPPORTUNITIES FOR THE UNINCORPORATED AREA, VILLAGES AND SMALLER TOWNS

WHEREAS Johnson County must take an innovative approach to equitable rural economic development and resilient communities by empowering them to identify, build, and leverage assets for economic advancement; and,

WHEREAS the COVID-19 pandemic and ensuing economic crisis, which started in 2020, exposed vulnerabilities and renewed the imperative to invest in rural communities; and,

WHEREAS Johnson County is committed to equitable economic development, which promotes the belief that all communities have the right to exist in a pollution-free, inclusive, and just economic environment that is free from persistent and systemic discrimination; and,

WHEREAS a goal of the Johnson County 2018 Comprehensive Plan was to adopt an economic development plan; and,

WHEREAS, the Board of Supervisors' Strategic Plan includes several economic development goals; and,

WHEREAS the Johnson County Planning, Development, and Sustainability Department, at the direction of the Board of Supervisors and in consultation with The Bill Menner Group and the Economic Development Committee, has prepared the *2022 Johnson County, Iowa Economic Development Plan: Opportunities for the Unincorporated Area, Villages and Smaller Towns*; and,

WHEREAS the proposed plan lists recommendations and potential steps the County can take to expand business and employment opportunities, diversify the tax base and improve quality of life in Johnson County; and,

WHEREAS Johnson County, amongst several other efforts to solicit stakeholder input on the plan, hosted 31 different stakeholder entities during the Johnson County Rural Economic Development Stakeholder Meeting on July 13, 2021; and,

WHEREAS the Johnson County Planning and Zoning Commission, the Food Policy Council, and the Economic Development Committee have recommended approval of said plan; and,

WHEREAS, after careful consideration during a public hearing, the Johnson County Board of Supervisors finds that it is necessary to adopt the *2022 Johnson County, Iowa Economic Development Plan: Opportunities for the Unincorporated Area, Villages and Smaller Towns*.

RESOLUTION NO. 01-13-22-08
RESOLUTION TO REQUIRE ALL VISITORS AND EMPLOYEES TO WEAR A FACE COVERING WHEN INSIDE COUNTY BUILDINGS

WHEREAS the Johnson County Board of Supervisors passed Resolution 08-12-21-01 on August 12, 2021 requiring the wearing of face coverings while inside county buildings regardless of vaccination status; and

WHEREAS the Johnson County Board of Supervisors passed Resolution 10-14-21-04 on October 14, 2021 extending the requirement to wear face coverings while inside county buildings regardless of vaccination status; and

WHEREAS the Johnson County Board of Supervisors approved the Vaccination, Testing and Face Covering policy on December 2, 2021 in compliance with the federal Occupational Health and Safety Administration Emergency Temporary Standards promulgated November 3, 2021; and

WHEREAS the Johnson County Public Health Department continues to recommend the wearing of face coverings when in any indoor public setting regardless of COVID-19 vaccination status; and

WHEREAS Johnson County was designated as high transmission by the CDC as of August 9, 2021 and remains at high transmission as of January 13, 2022; now

THEREFORE BE IT RESOLVED the Johnson County Board of Supervisors requires:

- (1) Visitors to Johnson County buildings to wear a face covering that covers both their nose and mouth completely while inside county buildings regardless of COVID-19 vaccination status; and
- (2) Fully vaccinated Johnson County employees are required to wear a face covering that covers both their nose and mouth completely while inside county buildings unless at their desk and socially distanced from others; and
- (3) Johnson County employees that are not fully vaccinated are required to wear a face covering at all times including: when inside county buildings and any other indoor location for work purposes unless teleworking from the employee's home, and when occupying a vehicle with another person for work purposes. Limited exceptions are when the employee is alone in a room with floor to ceiling walls and a closed door; when the employee is eating or drinking; for identification purposes in compliance with safety and security requirements; or if the employee is wearing a respirator or other facemask.

This requirement shall expire May 15, 2022, unless extended, shortened or modified.

WHEREAS, the Board of Supervisors (the “Board”) of Johnson County, Iowa (the “County”), has proposed to enter into a loan agreement (the “Essential County Purposes Loan Agreement”) in a principal amount not to exceed \$14,215,400, pursuant to the provisions of Sections 331.402, 331.441 and 331.443 of the Code of Iowa, for the purpose of paying the cost, to that extent, of the Essential County Purposes set out above, and has published notice of the proposed action and has held a hearing thereon on March 15, 2022; and

WHEREAS, the Board has also proposed to enter into a loan agreement (the “SEATS and Secondary Roads Fuel Station Paving Improvements Loan Agreement”) in a principal amount not to exceed \$125,000, pursuant to the provisions of Sections 331.402, 331.441 and 331.443 of the Code of Iowa, for the purpose of paying the cost, to that extent, of making paving improvements to a fuel station for the SEATS and Secondary Roads Department, and has published notice of the proposed action and has held a hearing thereon on March 15, 2022, and

WHEREAS, the Board has also proposed to enter into a loan agreement (the “Courthouse Renovation and Improvements Loan Agreement”) in a principal amount not to exceed \$750,000, pursuant to the provisions of Sections 331.402, 331.441 and 331.443 of the Code of Iowa, for the purpose of paying the cost, to that extent, of renovations and improvements to the Courthouse, and has published notice of the proposed action and has held a hearing thereon on March 15, 2022; and

WHEREAS, the Board has also proposed to enter into a loan agreement (the “Information Technology Improvements and Equipment Loan Agreement”) in a principal amount not to exceed \$1,195,105, pursuant to the provisions of Sections 331.402,

331.441 and 331.443 of the Code of Iowa, for the purpose of paying the cost, to that extent, of making improvements to and acquiring information technology equipment for County buildings, and has published notice of the proposed action and has held a hearing thereon on March 15, 2022; and

WHEREAS, the Board has also proposed to enter into a loan agreement (the “Voting Equipment Loan Agreement”) in a principal amount not to exceed \$15,000, pursuant to the provisions of Sections 331.402, 331.441 and 331.443 of the Code of Iowa, for the purpose of paying the cost, to that extent, of acquiring voting equipment and related technology for County buildings, and has published notice of the proposed action and has held a hearing thereon on March 15, 2022; and

WHEREAS, the Board has also proposed to enter into a loan agreement (the “County Farm Building Renovations and Improvements Loan Agreement”) in a principal amount not to exceed \$1,200,000, pursuant to the provisions of Sections 331.402, 331.441 and 331.443 of the Code of Iowa, for the purpose of paying the cost, to that extent, of remodeling, reconstructing, and equipping the County Farm historic site and grounds thereof, and has published notice of the proposed action and has held a hearing thereon on March 15, 2022; and

WHEREAS, the Board has also proposed to enter into a loan agreement (the “County Sheriff Vehicles Loan Agreement”) in a principal amount not to exceed \$276,185, pursuant to the provisions of Sections 331.402, 331.441 and 331.442 of the Code of Iowa, for the purpose of paying the cost, to that extent, of acquiring vehicles for the County Sheriff, and has published notice of the proposed action and has held a hearing thereon on March 15, 2022, and no petition has been filed asking that the question of entering into the County Sheriff Vehicles Loan Agreement be submitted to the registered voters of the County; and

WHEREAS, the Board has also proposed to enter into a loan agreement (the “SEATS Fleet Shop Equipment Loan Agreement”) in a principal amount not to exceed \$11,550, pursuant to the provisions of Sections 331.402, 331.441 and 331.442 of the Code of Iowa, for the purpose of paying the cost, to that extent, of acquiring equipment for the SEATS fleet shop, and has published notice of the proposed action and has held a hearing thereon on March 15, 2022, and no petition has been filed asking that the question of entering into the SEATS Fleet Shop Equipment Loan Agreement be submitted to the registered voters of the County; and

WHEREAS, the Board has also proposed to enter into a loan agreement (the “Ambulance Vehicles Loan Agreement”) in a principal amount not to exceed \$290,000, pursuant to the provisions of Sections 331.402, 331.441 and 331.442 of the Code of Iowa, for the purpose of paying the cost, to that extent, of acquiring vehicles for the Ambulance Department, and has published notice of the proposed action and has held a hearing thereon on March 15, 2022, and no petition has been filed asking that the question of entering into the Ambulance Vehicles Loan Agreement be submitted to the registered voters of the County; and

WHEREAS, the Board has also proposed to enter into a loan agreement (the “Ambulance Equipment Loan Agreement”) in a principal amount not to exceed \$82,260, pursuant to

the provisions of Sections 331.402, 331.441 and 331.442 of the Code of Iowa, for the purpose of paying the cost, to that extent, of acquiring equipment for the Ambulance Department, and has published notice of the proposed action and has held a hearing thereon on March 15, 2022, and no petition has been filed asking that the question of entering into the Ambulance Equipment Loan Agreement be submitted to the registered voters of the County; and

Chapter 2 Sustainability - [Section 2.1] - Profile Sustainability Policies & Programs – Green Buildings and Renewable Energy subsection – Solar Permitting (Pg. 32)

This section references solar permitting processes, including the Solarize programs. It also mentions how the County has previously streamlined the utility-scale [solar] inspection process.

Staff recommends adding a statement to this paragraph as follows:

From 2015 to 2017, the county improved the process for solar array permitting. Checklists and other guidance are now provided online. An ordinance amendment in 2017 ensured that solar is allowed as an accessory use in all zoning districts. In addition, Building Services streamlined the application process to three days for approval of a non-utility scale installation. They The County also streamlined the utility scale inspection process-, and ~~in 2017, Johnson County~~ earned SolSmart Gold for its solar improvement efforts. Looking forward, Johnson County intends to continue being a leader in supporting the development of renewable energy production in the county, including both private- and utility-scale solar and wind.

Chapter 2 Sustainability - [Section 2.2] - Priorities Leader in Green Practices (Pg. 40)

The Plan discusses the County's efforts in being a leader in green practices including soil and water conservation assistance, sustainability grants programs, and education and public awareness.

Staff recommends adding a statement to this paragraph as follows:

Johnson County provides soil and water conservation services to homeowners and businesses, and guidance on solar installations. The County supports expanded renewable energy production, including both private and utility scale solar and wind, to reduce dependency on fossil fuels. A sustainability grants program provides funding and technical assistance for nonprofit groups to compile energy efficiencies and other projects. However, there is opportunity to increase public awareness and education about sustainability as the County models best management practices. Creating new partnerships and seeking out new ways to share the benefits of these programs is one way to accomplish this goal.

Chapter 2 – Sustainability – [Section 2.3] – Goals Goal SUSTAINABILITY 4 (Pg. 43 [13, 48, 143])

Staff recommends amending Sustainability Goal 4 as follows to incorporate a new strategy and associate action steps with direct reference to supporting renewable energy development in the county, including utility-scale solar.

SUSTAINABILITY 4 – Support and advance energy efficiency, resource conservation, and renewable energy programs, policies, and uses.

Strategy 1 – Continue partnerships with nonprofit organizations to improve their operations.

Strategy 2 – Continue to be a resource to the community on sustainable practices.

Action 1 – Complete website enhancements to better promote available services.

Action 2 – Provide educational events.

Action 3 – Establish other programs through partnerships with cities, the University of Iowa, community school districts, and other organizations

Strategy 3 – Support the development of utility scale solar in Johnson County.

Action 1 – Identify and mitigate barriers to the appropriate development and use of energy efficiency, energy conservation, and renewable energy, including utility scale solar.

Action 2 – Incorporate best practices into programs, policies, and code.

Action 3 – Ensure consideration of natural resource and agricultural protection.

Chapter 3 Local Economy – [Section 3.3] – Goals

Goal LOCAL ECONOMY 3 (Pg. 71 [75, 146])

Staff recommends amending Local Economy Goal 3 as follows to incorporate a new strategy with direct reference to supporting renewable energy development in the county, including utility-scale solar.

LOCAL ECONOMY 3 – Encourage sustainable agricultural activities.

Strategy 4 - Support the development of utility scale solar in Johnson County.

Chapter 4 – Infrastructure and Amenities – [Section 4.2] – Priorities

Provision of Infrastructure & Utilities (Pg. 87)

The Plan discusses provision of water, wastewater, energy, and telecommunications services. It also references the County’s role in ensuring utilities *can be* provided when reviewing a development application even though the County itself is not the provider of those utilities.

Staff recommends emending this section to add several statements to this paragraph as follows:

Provision of Infrastructure & Utilities

Potable water and waste water systems are site specific. ~~While E~~energy and telecommunication utilities are provided by private companies or cooperatives, ~~not the County,~~ the County encourages the development of forward-thinking infrastructure such as utility scale solar and universally available high-speed internet in Johnson County. Johnson County’s role in permitting and reviewing these elements is twofold: 1) to assure ~~these existing~~ services can be made available to new buildable lots before approving a development application, and are done so per county and state law for public health, safety and welfare; and 2) to support applications that seek to responsibly establish or expand these infrastructure and utility facilities in the county.

Chapter 4 – Infrastructure and Amenities – [Section 4.3] – Goals

Goal INFRASTRUCTURE & AMENITIES 5 (Pg. 90 [94, 149])

Staff recommends amending Infrastructure and Amenities Goal 2 as follows to incorporate a new Strategy 6 to provide direct reference to supporting development of renewable energy in the county at both private- and utility-scale.

INFRASTRUCTURE & AMENITIES 5 – Support amenities that enhance livability and quality of life.

Strategy 6 - Support the development of renewable energy in Johnson County, including both private and utility scale solar and wind.

Chapter 5 – Land Use – [Section 5.3] – Goals

Goal LAND USE 5 (Pg. 108-109 [121, 153])

Staff recommends amending Land Use Goal 5 as follows to incorporate a new Strategy 3 to provide direct reference to ensuring the consideration of natural resource impact and agricultural protection while reviewing development of renewable energy in the county at both private- and utility-scale.

LAND USE 5 – Continue to protect and improve Johnson County’s natural resources: land, water, and air.

Strategy 3 - Ensure consideration of natural resource and agricultural protection while supporting the development of renewable energy in Johnson County, including both private and utility scale solar and wind.

Chapter 5 – Land Use – [Section 5.3] – Future Land Use Tools

Goal LAND USE 5 (Pg. 112)

Staff recommends amending written description of the Agricultural Future Land Use Category within the Future Land Use Tools section to incorporate language to provide direct reference to utility-scale being a potential land use in the Agricultural Future Land Use Category.

Agricultural

Typical uses include land devoted to agriculture, including crop production and animal husbandry, and very limited residential development to include farmstead splits and small farm development. Less typical uses may also include commercial uses related to and/or supporting agricultural uses, rural recreation and park areas, utility scale renewable energy generation including wind and solar, mining and mineral extraction, and other land-intensive uses which may not be appropriate in other future land use categories. This land use category ~~may~~ also include areas of land significantly impacted by wetlands or floodplain and areas of steep topography or natural tree cover or other sensitive areas preserved as open space.

Limited residential development may be allowed on a case-by-case basis (rezoning a maximum of 21.99 acres to allow no more than one dwelling) if all elements in the Future Land Use Development Guidelines are achieved. Residential development should be associated with food production or be consistent with the historic use of the property and area. The intent of allowing limited residential development is to allow the Board of Supervisors to correct legal non-conforming uses and zoning packages and/or to allow an existing dwelling to be separated from a larger farm where the established use of the property is residential, ~~and~~ it may also create/serve as a mechanism to allow for small farm development that does not otherwise qualify for agricultural exemption. Rezoning that result in the creation of residential development that does not reflect the agricultural nature of this category should not be approved.

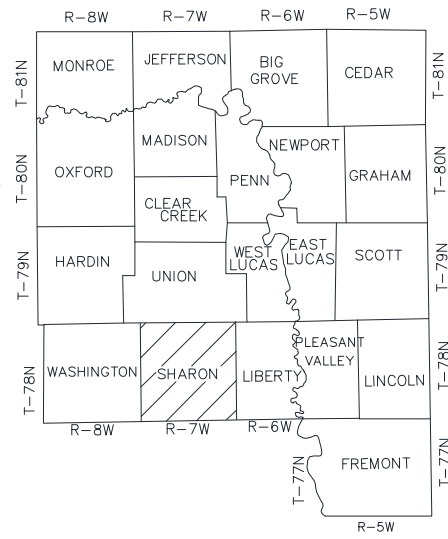

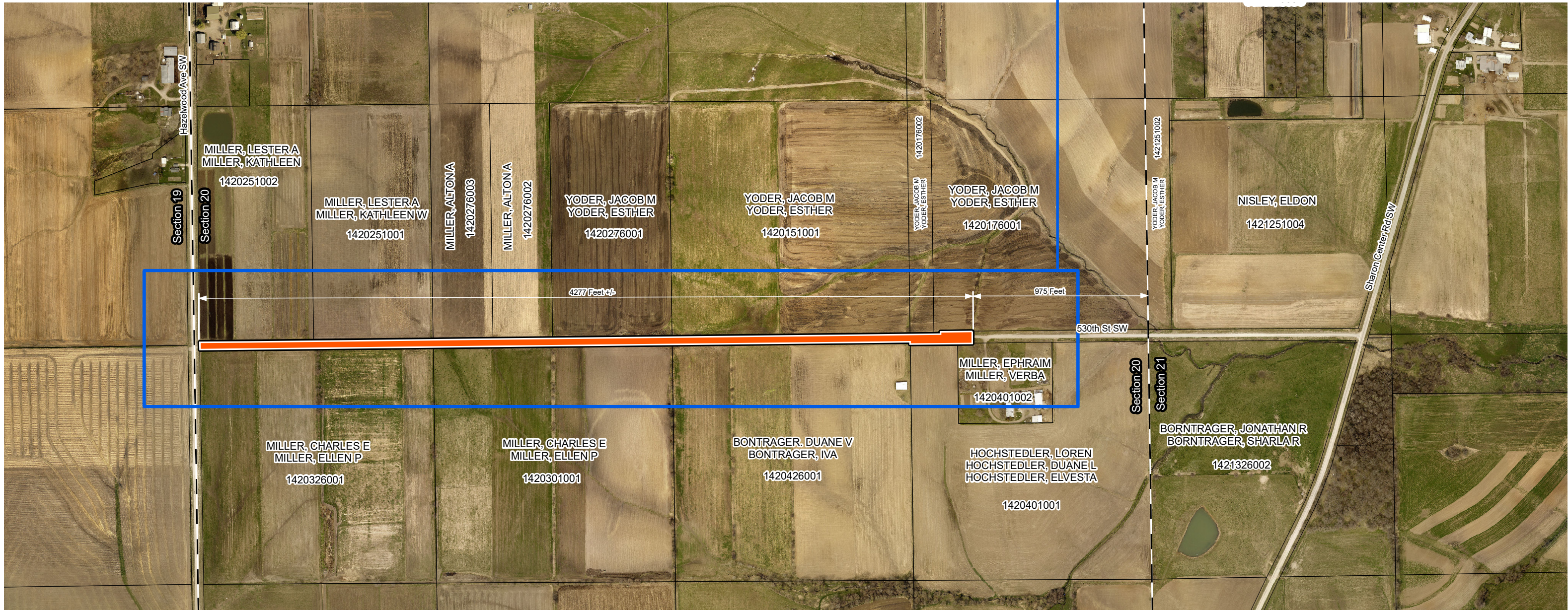

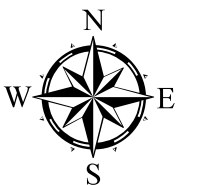
Portion of 530th St SW requested to be vacated
