  - b) Senior Day Johnson County Fair not many stopped to talk but liked picking up outreach materials
  - c) Consumer Numbers rising
    - i. FY23 40 consumers, 92 contacts
    - ii. FY22 127 Consumers, 645 contacts (160 referrals not listed as consumers from 10/29/21-6/30/22)
    - iii. FY21 88 Consumers, 425 contacts

  - a) FY22 end of fiscal year report
    - \$2,174 spent (44% of budget) all on outreach except \$306 annual subscription for Constant Contact
    - ii. Paid June and July dues for 7 TRAIL scholarships for 7 individuals needing assistance
