Medicare Open Enrollment

You can enroll in Medicare health and drug plans from October 15 – December 7. Get ready for Medicare's Open Enrollment with these 5 tips:

1) Check your mail. You may get important notices from Medicare or Social Security. If you're in a Medicare plan, you'll get an Annual Notice of Changes (ANOC) telling you of any changes in coverage, costs, or





service area. Note any 2024 changes to your health coverage or any <u>Extra Help</u> you may get to pay for prescription drugs.

You may also get brochures and other marketing materials from insurance companies that offer Medicare health and prescription drug plans. Remember — plans aren't allowed to call or come to your home without an invitation from you. <u>Find out how to protect yourself.</u>

2) Think about your Medicare coverage needs for 2024. Carefully review your current Medicare coverage, and note any upcoming changes to your costs or benefits. Decide if your current Medicare coverage will meet your needs for the year ahead. If you like your current coverage, and it's still available for 2023, you don't need to take any action to keep it.

3) Review your <u>2024 "Medicare & You" handbook</u>. It has information about Medicare coverage and Medicare plans in your area. If you want to get your handbook electronically, you can go paperless by <u>logging into (or creating) your secure Medicare account.</u>

4) <u>Preview 2024 health and prescription drug plans.</u> We make it easy to compare coverage options and shop for health plans. For a personalized search, <u>log in or create an account</u> (if you have a Medicare Number) to create or access a list of your drugs, compare

your current Medicare plan to others, and see prices based on any help you get with drug costs.

5) Get personalized help in your community. For local assistance contact a Senior Health Insurance Information Program (SHIIP) counselor. Schedule a meeting by contacting the Iowa City Senior Center (319-356-5220) or Mercy Hospital (319-339-3658). You can also schedule appointments online through the Senior Center by <u>clicking here.</u>

Tremble Clefs, a therapeutic singing group for individuals with Parkinson's disease (PD), caregivers, and family members, will begin rehearsals this fall at the Iowa City Senior Center. Tremble Clefs was founded in Scottsdale, AZ in 1994 and is expanding to Iowa City to engage the PD community in music therapy and social support. The loss of voice, communication difficulties resulting in a decreased volume of voice and lung capacity, and

depression are the common symptoms of PD. This weekly program will provide vocal, breathing, and movement exercises that benefit the participants to meet their specific needs in PD and create a supportive and therapeutic environment for the individuals with PD and their caregivers. Sun Joo Lee, a board-certified music therapist and a director of Tremble Clef, AZ, who has been leading the group since 2008, will facilitate the program in Iowa City. 
2023 TRAIL Senior Housing & Services Guide

The 2023 Johnson County Senior Housing and Services Guide is a quite informative, 60-page document. Over the last year, eight volunteers with TRAIL of Johnson County have put more than 100 hours of work into researching senior services and housing options for seniors in this county for the guide. It includes amenities, services, and costs for:

★ 20 senior living facilities, includingindependent living, assisted living, and memory care

- ★ 4 skilled nursing facilities
- ★ 2 in-home medical care providers
- ★ 14 in-home non-medical care providers
- ★ 2 rehabilitation facilities
- ★ 2 hospice agencies

Upcoming Lego Builds

The Johnson County Livable Community for Successful Aging Policy Board's Housing Action Team, in collaboration with the Johnson County Affordable Housing Coalition and the Greater Iowa City Homebuilders Association will host a Lego-built accessory dwelling unit (ADU) design competition in October.



The Lego build competitions are funded by AARP to

educate the public on the community benefits of including the construction of ADUs in zoning and building codes. Policy changes to minimize lengthy application processes, decrease high fees, and eliminate harsh regulations associated with the development of ADUs will increase the availability of more affordable types of housing for individuals aged 50- plus. Kids aged 17 and younger are eligible to compete at each of the events for the \$50 first prize and \$25 2nd prize awards.

Volunteers Needed for VITA

Volunteer Income Tax Assistance (VITA) is a national IRS sponsored program that provides free tax preparation of

federal and state tax returns for low income households. On average, it costs a taxpayer nearly \$300 to have their return prepared and filed by a tax firm. This money can instead be used for basic needs, such as groceries and rent. Volunteers are critical to the success of the VITA program.

VITA volunteers are needed to help prepare and file tax returns. No previous experience is necessary. Volunteers will complete IRS training to become certified tax preparers.
