- 1. Introductions/Program Updates
  - a. Updates:
    - i. NCJC new FSW, Jennifer, passed certification & program is completely certified now
    - ii. Jessie (UAY) new staff, Anthony, working on building caseload, getting started on new projects
  
- 2. Review FY24 Q1 DAISEY data
  - a. Outputs
    - i. numbers match up for both NC & UAY
  - b. Quality
    - i. NCJC- numbers of home visits are based on forms submitted,
      - 1. uses those same submitted forms for billings, so they should match up
    - ii. UAY numbers also match
  - c. EPDS (postnatal depression screening)
    - i. Andy thinks number comes from either those that say they are pregnant or 2 years out from birth, seems low might be because programs are not required to enter EPDS data into DASIEY
    - ii. Jessie agrees that numbers for UAY seem low
    - iii. Sam will inquire with state
  - d. ASQ-3
    - i. Both NCJC & UAY providers can see ASQ-3 report/ECI doesn't have access

- ii. State only required programs to mark that a screening had been completed
  - 1. However numbers are skewed if not all the ASQ information is inputted
  - 2. Need clarification b/c NCJC uses GOLD screenings rather than ASQ
  - 3. Children are receiving ASQs through doc/school but that data not being inputted into DAISEY, only that the ASQ screening happened
  
- 3. Parents as Teachers Affiliate Requirements Review and Brainstorm
  - i. Parents as teachers is curriculum
    - 1. Rumblings at state level that FS programs will be required to become affiliates rather than subscribers
    - 2. expensive \$4000 startup plus \$2000 and \$2000 yearly recertification
    - 3. Sam compiled a list of questions to ask at ECI conference about affiliate status as there are a good number of programs that are affiliated
    - 4. Another requirement is a Parent advisory group
      - a. This group could morph into that
        - i. Including ECI board members, parents, contractors
