

Older Adults Now Able to Receive Additional Dose of Updated COVID-19 Vaccine

Last week, CDC Director Mandy Cohen endorsed the CDC Advisory Committee on Immunization Practices' (ACIP) recommendation for adults ages 65 years and older to receive an additional updated 2023-2024 COVID-19 vaccine dose. The recommendation acknowledges the increased risk of severe disease from COVID-19 in older adults, along with the currently available data on vaccine effectiveness.

Previous **CDC recommendations** ensured that people who are immunocompromised are already eligible for additional doses of the COVID-19 vaccine.

Data continues to show the importance of vaccination to protect those most at risk for severe outcomes of COVID-19. An additional dose of the updated COVID-19 vaccine may restore protection that has waned since a fall vaccine dose, providing increased protection to adults ages 65 years and older.

Adults 65 years and older are disproportionately impacted by COVID-19, with more than half of COVID-19 hospitalizations during October 2023 to December 2023 occurring in this age group.

CDC and ACIP will continue to monitor COVID-19 vaccine safety and effectiveness. CDC continues to recommend that everyone stay up to date on their COVID-19 vaccines, especially people with weakened immune systems.

- This service aims to keep the grass within the City of Iowa City's requirement of 10 inches or shorter and the City of Coralville's requirement of 10 inches or shorter.
- Mowing is every 7 to 10 days or so, weather permitting.
- Lawn mowing calendar will be mailed to approved clients.



March is colorectal cancer awareness month! Colorectal cancer affects 1 out of every 25 Americans, but it is highly treatable and can even be prevented when caught early enough by screening.

The American Cancer Society recommends that adults aged 45 years and older undergo regular screening with either a high-sensitivity stool-based test (such as a FIT test) every 1-3 years, and/or a visual exam (colonoscopy or flexible sigmoidoscopy) every 5-10 years, based on your individual health and risk factors. **Talk to your doctor about making sure you are up-to-date with screenings that are right for you.**

Iowa Rent Reimbursement

The Iowa Department of Health and Human Services (HHS) will manage the Rent Reimbursement program.

Income Limits

- To be eligible for Rent Reimbursement for claim year 2021, your total annual household income must be less than \$24,354.
- To be eligible for Rent Reimbursement for claim year 2022, your total annual household income must be less than \$25,328

Free Tax Aide at the Iowa City Senior Center in Spring 2024

Free tax preparation services are being offered by appointment at the Iowa City Senior Center through April 15, 2024. Low to moderate income taxpayers, especially those age 60+, can receive this free service, provided by trained volunteers through a partnership with the AARP Foundation Tax-Aide Program. **Make an appointment online** or call 319-356-5220 to sign up by phone.

Clients will schedule an intake appointment to drop off and inventory their tax-related materials and sign some forms. A counselor prepares the tax return while the client waits in the 1st floor lobby, consults the client with any questions, then reviews the completed return with the client before e-filing. The process takes about 60-90 minutes.

To have taxes prepared, clients must bring:

- Copies of federal and state tax returns for the most recent year filed
- Photo ID and Social Security card for each taxpayer included on the return
- Bank routing/account number for direct deposit/debit
- W-2 forms, 1099 forms, other statements of income
 - If you receive Social Security benefits, you must bring your SSA-1099 form to your appointment. If you don't have one, contact Social Security to request a replacement.
- If applicable, additional documentation detailing itemized deductions and credits/adjustments
- 1095-A forms if you purchased insurance through the Marketplace (Exchange)
