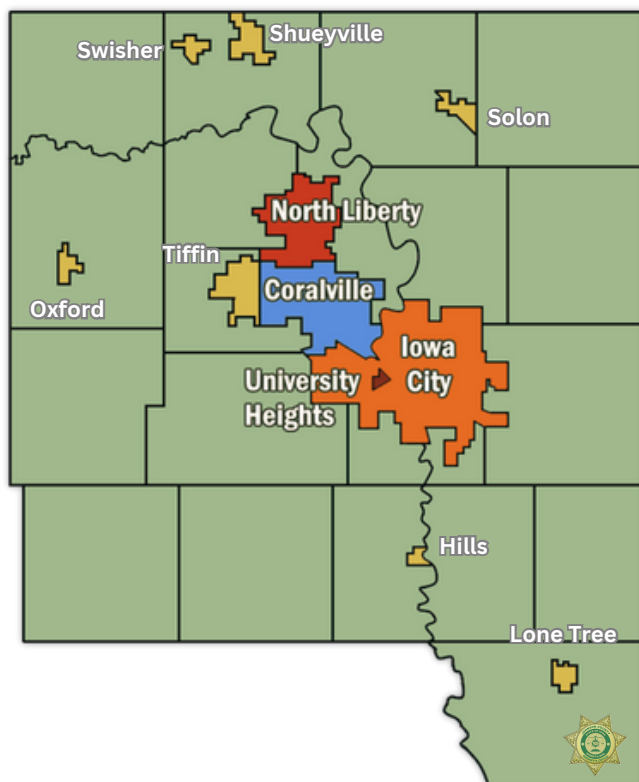

The Office of the Sheriff

The Sheriff is the county's principal peace officer for the unincorporated areas of Johnson County as well as the cities of Hills, Lone Tree, Oxford, Shueyville, Solon, Swisher and Tiffin. Sheriffs are elected into office every four years and are the only elected law enforcement officers in the State of Iowa.

Duties are varied and for the most part defined by the Iowa Code to include:

- Enforce the law of the State of Iowa
- Enforce county ordinances
- Conduct criminal investigations
- Provide law enforcement services to the county's courthouse
- Operate the county jail and oversee the custody of incarcerated offenders
- Maintain the Sex Offender Registry
- Issue gun permits
- Carry out civil process services
- Patrol rural Johnson County
- Respond to any and all disasters within the county
- Assist other law enforcement agencies
- Serve mental health commitments

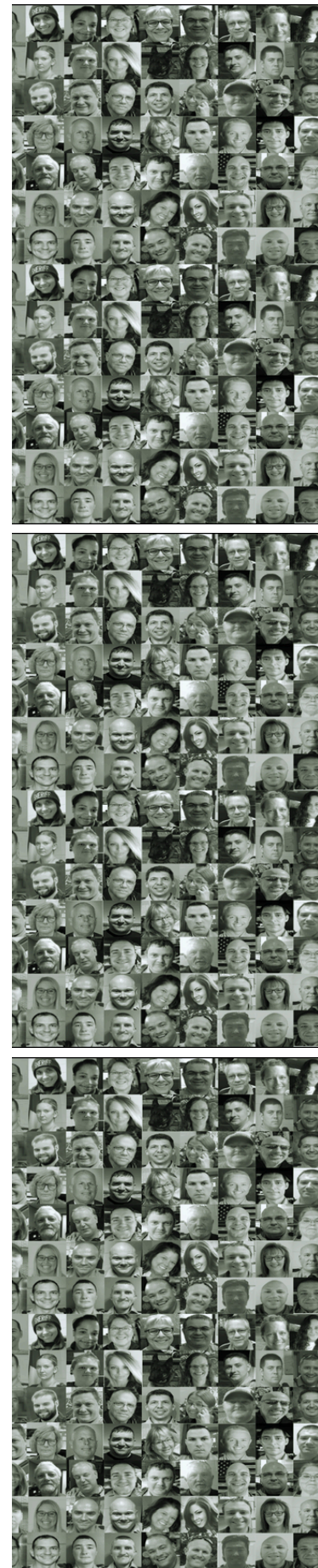

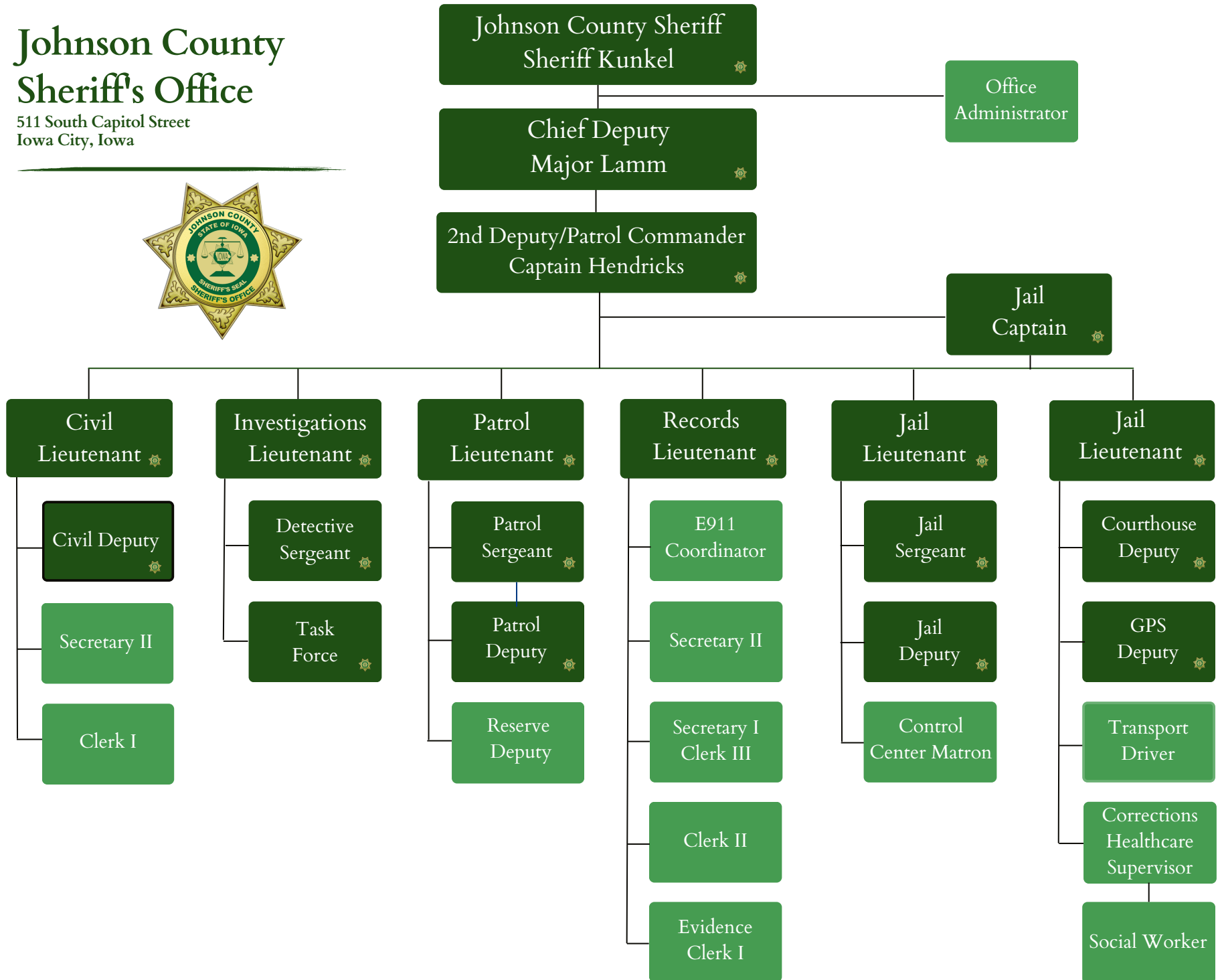

- No contact/restraining orders

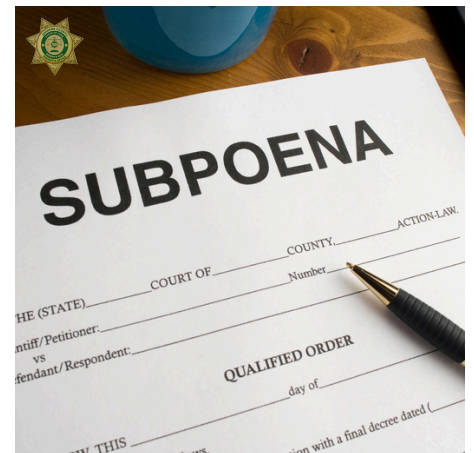

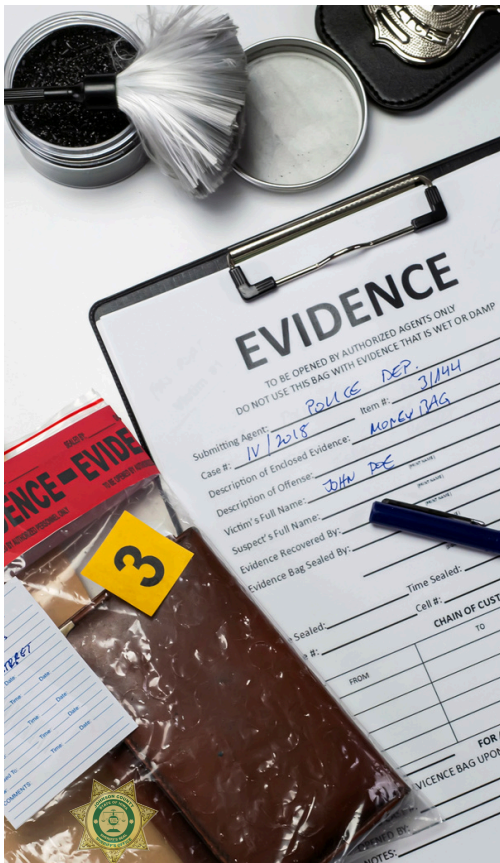

Investigations



The Investigation Division is comprised of one Detective Lieutenant, five Detective Sergeants and one deputy assigned to the Johnson County Drug Task Force. Detectives within the division cover any in-depth investigation that may require specialized training. Some of these investigations include burglary, critical incidents, robbery, sexual assault, fraud, murder, arson and internal investigations. The Investigation Division also investigates any suspicious or unattended death in coordination with the Johnson County Medical Examiner's Office.

The Iowa Code requires all law enforcement agencies to submit reports of crime and arrests to the Bureau of Criminal Investigations. Uniform Crime Reports (UCR) are categorized into Group A and Group B offenses. Group A offenses are serious crimes and separated into violent crime offenses which include criminal homicide, forcible rape, robbery and aggravated assault and property crime offenses which include burglary, larceny, motor vehicle theft and arson. Group B offenses are considered less serious offenses such as liquor law violations, disorderly conduct, trespass offenses and all other arrests not covered by Group A.

Criminal Law





JFACT (Johnson County Joint Forensic Analysis Cyber Team) was founded in 2021 as a joint endeavor of the Johnson County Sheriff's Office, Iowa City Police Department, and University of Iowa Department of Public Safety to address the growing need for digital forensic services and to better confront electronic child exploitation. During this, its third year of operation, JFACT saw the addition of task force members from the Coralville Police Department and the North Liberty Police Department. School and community outreach, as well as law enforcement education, are also part of JFACT's proactive approach to improving child safety, crime prevention, and electronic evidence handling.

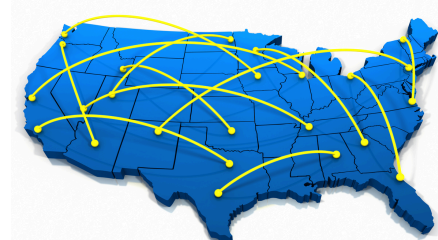

JFACT team members are investigators affiliated with the Iowa Internet Crimes Against Children (ICAC) task force, and also provide technical assistance to other investigators related to a multitude of serious crimes. In 2023, JFACT processed over 1,200 items of electronic evidence for 39 state, local, and federal law enforcement agencies. More than 300 items of electronic evidence were processed for Internet

Crimes Against Children investigations alone.

As part of JFACT's goal to provide the highest level of technical expertise, team members are credentialed by the International Association of Computer Investigative Specialists, an accredited body recognized by the Forensic Specialties Accreditation Board (FSAB).

Jail Division



The Johnson County Sheriff's Office operates the only jail in the county. The original jail, constructed in 1899, was located behind the Johnson County Courthouse on South Clinton Street. In 1979 construction began on the existing jail and was completed in 1981.

The new jail housed 46 inmates but was remodeled within a few years. All cells were double bunked increasing capacity to 92 though our occupational capacity is 65. Jail overcrowding remains a problem to this day and inmates are transported to other facilities where Johnson County pays a daily housing fee. Over the last 22 years the Johnson County Sheriff's Office has paid over \$15,800,000 to house inmates out of county.

Average Daily Population: The daily population of individuals in the custody of Johnson County Sheriff. This includes inmates housed in the Johnson County Jail, Johnson County inmates house out of county, and those out on Electronic Monitoring.

Jail Bookings: Total numbers of individuals booked at the Johnson County Jail.

Out of County Inmate Housing Costs: Cost to house Johnson County inmates at other facilities due to limited space in the Johnson County Jail.

Total Transports: This is the total transports for inmate transfers and court order transports.

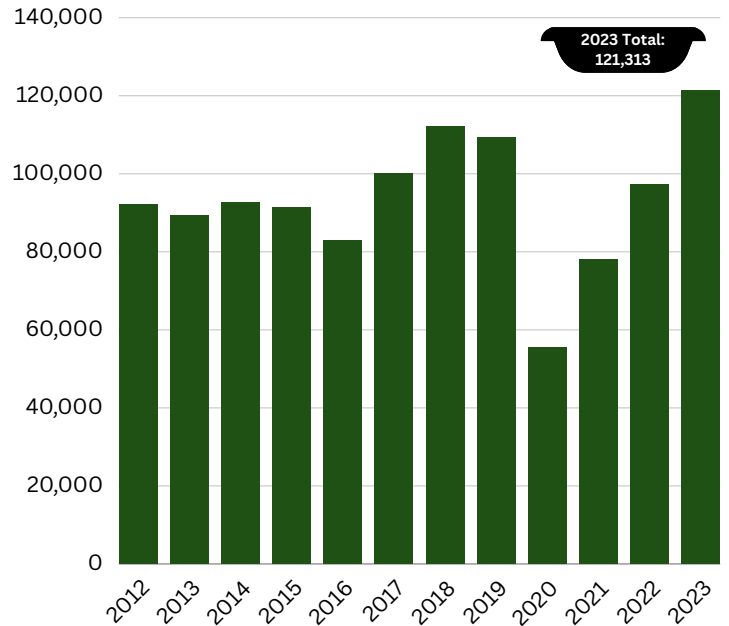

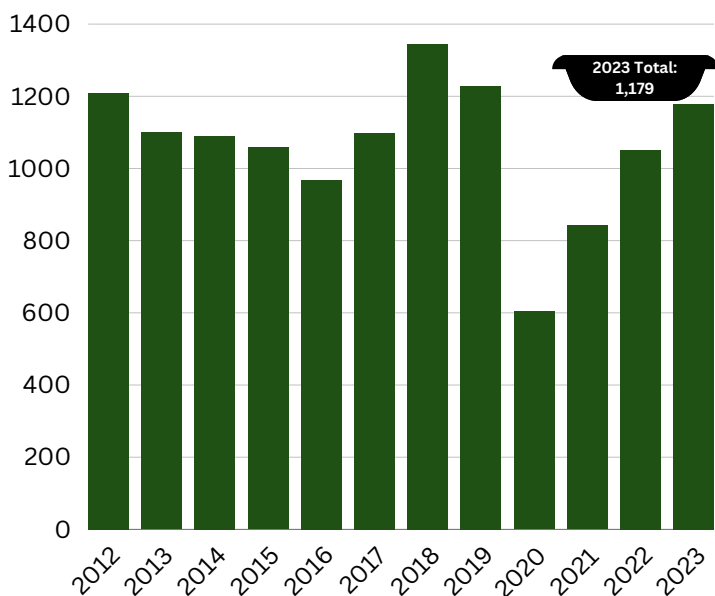

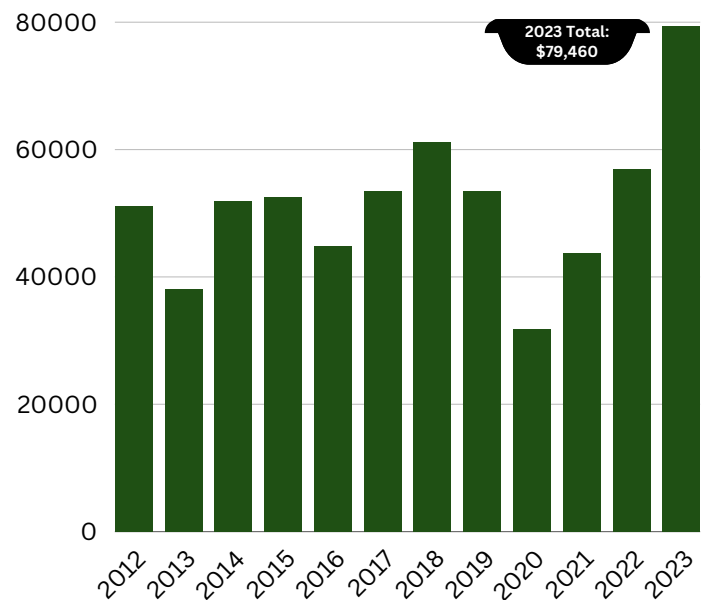
Transport Mileage



Transport Totals

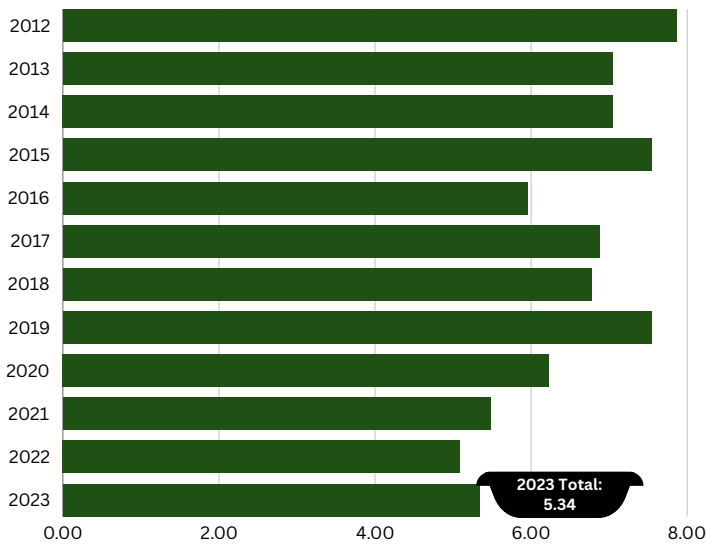

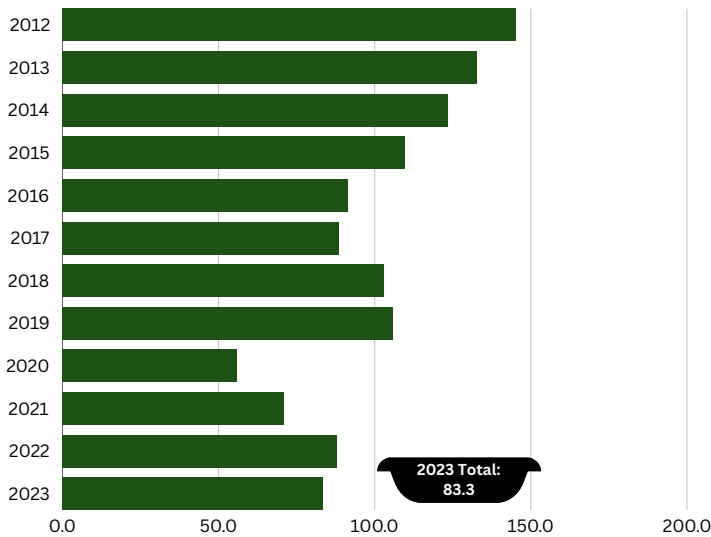

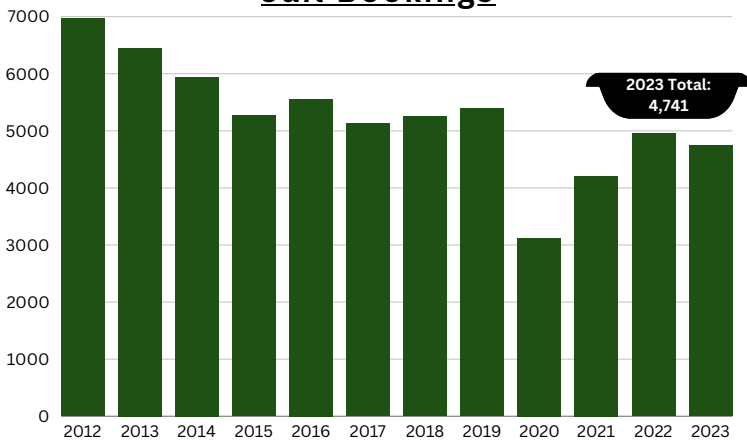
Average Length of Stay



Average Daily Population



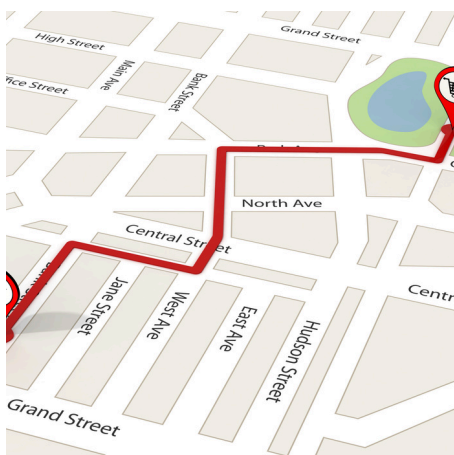

GPS Monitoring



In June of 2022, the Johnson County Sheriff's Office began a GPS Monitoring Program. The program was modeled after a longstanding pre-trial GPS program in Pitt County, North Carolina.

The pilot project in Johnson County began as another way to divert people from jail and prevent and reduce the number of no-contact violations promoting victim safety while affording defendants the opportunity to maintain employment, education and treatment.

The initial project scope was eventually expanded and alleviated jail staff of extra duties including Work Release, Mental Health Commitments, Sex Offender Registry and Compliance checks.

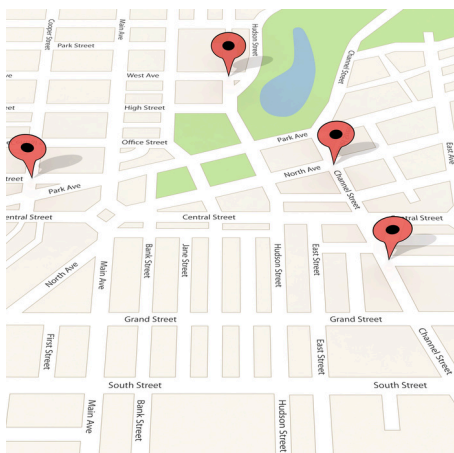

Mental Health



In 2023 the Johnson County Sheriff's Office continued their efforts to enhance external and internal programs that focus on mental illness with the goal of ensuring the safety of all citizens, responding effectively and improving access to services and supports for people with mental illness.

Medical and mental health issues are taken very seriously at the Johnson County Jail. As a part of the admission procedure, a medical history intake form is completed for each person admitted to the jail which includes a screening process for potential self-injury or suicide risk. 24 hour, 7 days a week medical services are also available through the University of Iowa Hospitals & Clinics and the Emergency Room physician assistant. A registered nurse is present in the facility Monday - Friday to assist with medication management and respond to acute issues and/or emergencies that arise. Incarcerated individuals also have access to an in-house social worker and can be referred to meet with a contracted psychiatric specialist from the Abbe Center. The arrangements with UIHC and the Abbe Center ensure that all incarcerated individuals receive necessary medical, mental health and dental needs which are known to the jail staff.



The Corrections Social Worker provides behavioral skill development and/or crisis intervention to individuals incarcerated at the Johnson County Jail. They meet with inmates and present resources from the community that are beneficial to their specific needs along with being a listening ear to other problems inmates may be experiencing. The Corrections Social Worker also works with the Johnson County Attorney's Office, University of Iowa, Abbe Center, Guidelink Center, Shelter House, RVAP, Probation Officers, Hope House, Inside Out, NAMI, and many other organizations to provide opportunities upon their release.



In 2023, the Social Worker met with 174 individuals for a total of 695 meetings.

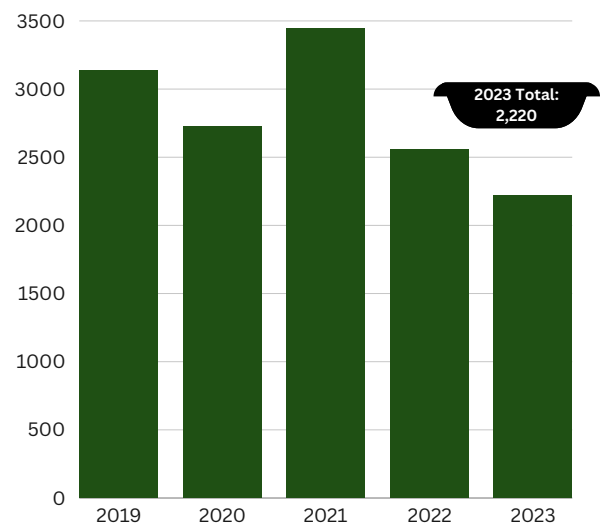
Patrol Division

The Patrol Division consists of a Patrol Commander, a Lieutenant, four Sergeants, and 26 Deputies. This division offers essential law enforcement services for the unincorporated areas of Johnson County. Additionally, it provides contract law enforcement services to the municipalities of Hills, Lone Tree, Oxford, Shueyville, Solon, Swisher, and Tiffin. Deputies are responsible for patrolling 36 miles of interstate highways, 54 miles of state highways, and 909 miles of county roads.

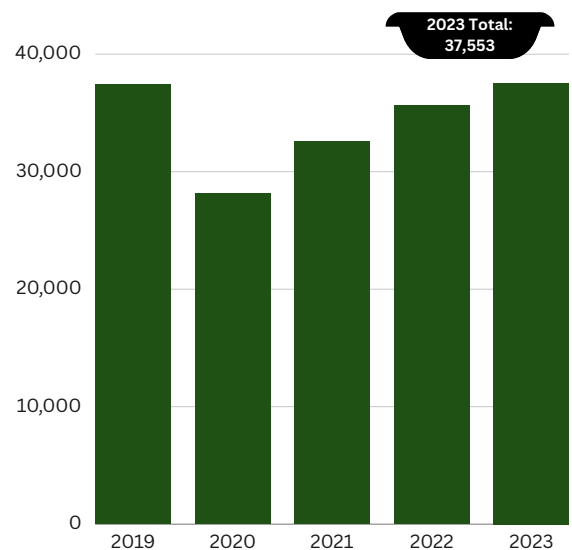

Calls for Service

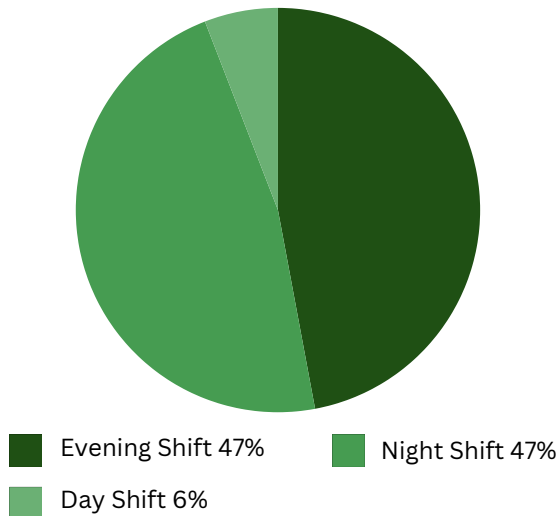


Pursuits

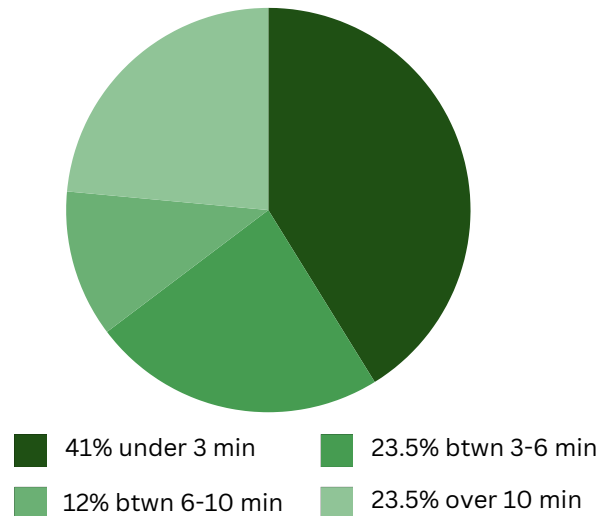
The Johnson County Sheriff's Office recognizes the fact that pursuits are inherently dangerous. For that reason pursuits go through multiple layers of review to ensure that protocol is being followed and to identify officer safety issues, potential risks to the public, training needs and liability issues. All pursuits are subject to an after-action review which is completed by the pursuing deputy's immediate supervisor and includes the deputy who initiated the pursuit.

During the year 2023 deputies with the Johnson County Sheriff's Office engaged in seventeen pursuits which is a 29% decrease from 2022. The seventeen pursuits are broken down as follows:

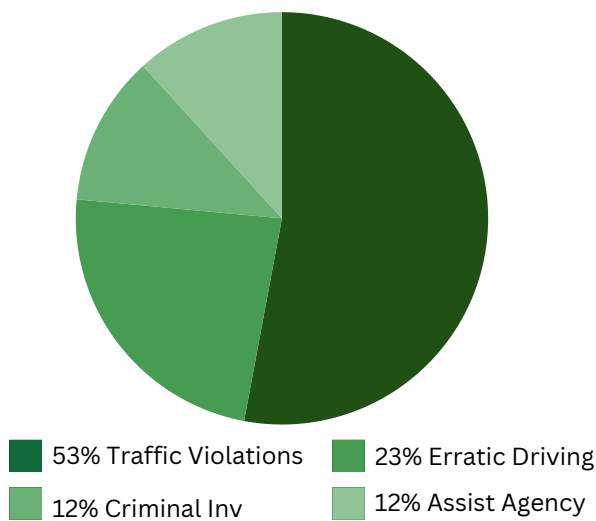
Shifts that pursuits occurred



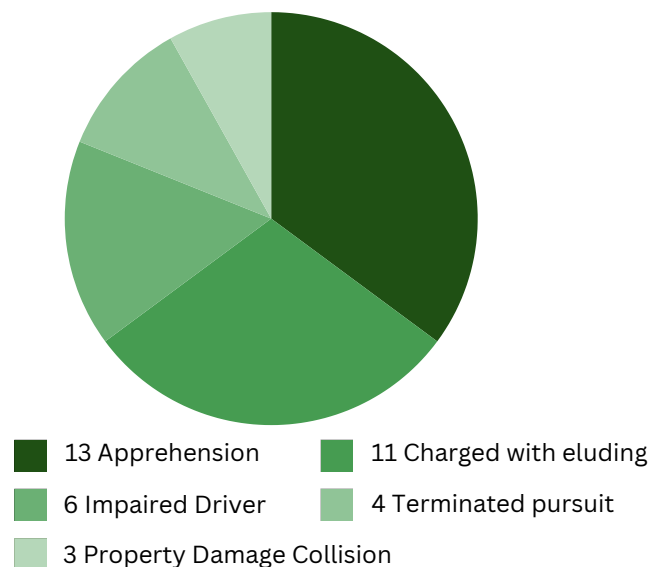
Duration of pursuits (in minutes)

Use of Force

The Sheriff's Office began formal tracking use of force incidents in May 2023. Tracking Use of force ensures transparency and help identify training needs.

What does Use of Force mean?

"Use of force" can be defined as a situation in which a law enforcement officer interacts with an unwilling individual and force is used, either in self-defense or to compel compliance.

The Johnson County Sheriff's Office determines a situation is a use of force incident anytime a deputy places hands on a person who is non-compliant. The most common occurrences for use of force incidents at the Johnson County Sheriff's Office are when taking someone into custody or when restraining someone engaging in self-harm.

Johnson County separates use of force incidents into two categories: "**In custody**" and "**Not in custody**".

Use of Force - In Custody (Jail)

The Johnson County Jail processed 3197 bookings from May through December 2023. During this time Jail Deputies were involved in a total of **67** use of force incidents. Jail use of force is broken down into two categories: **Less than 24hrs** in custody and **More than 24hrs** in custody.

Individuals held **less than 24hrs.** are typically only in custody for jail booking process and an initial court appearance in front of a Judge. It is not uncommon for these individuals to be under the influence of alcohol or drugs during their time at the Johnson County Jail. There were **30** use of force incidents in this category. This equates to less than .01% of all bookings.

Individuals held **more than 24hrs** are typically those individuals who are held on bond for more serious offenses or those who are serving a sentence. There were **37** use of force incidents in this category. Furthermore, of the 37 use of force incidents with someone in custody for more then 24 hours, six individuals account for 78% (29 of 37) of use of force incidents. The six detainees who account for 78% use of force incidents are all considered high-need inmates based on their behaviors.

Use of Force - Not in Custody (Patrol)

May through December 2023, the Johnson County Sheriff's Office logged 26,386 calls for service. During the time, Patrol Deputies were involved in **27** use of force incidents. This equates to .001% of calls for service resulting in use of force.

Overall

The Johnson County Sheriff's Office reviews all use of force incidents. There were no serious injuries reported for any of the **94** use of force incidents recorded from May through December 2023.

Records Division



The Records Division maintains all of the records for individuals booked in to the jail, investigative reports, and accident reports. This Division is also responsible for fulfilling records requests for both internal and external customers.

In addition, the Records Division processes all firearm permit applications for residents of Johnson County and maintains the Iowa Sex Offender Registry information for any sex offender that resides, works or travels to Johnson County.

Reserves

In 2023, the Reserve Unit continued its role as a support division at the Sheriff's Office, providing staffing resources primarily to the Patrol Division. Reserve deputies are a fixture at town festivals and special events, assist with crime prevention programs, and provide a uniformed presence at high school games and dances, allowing patrol deputies to focus on their normal duties alleviating the need for extra overtime. Those Reserves who have completed advanced field training augment patrol deputies during periods of minimum staffing or anticipated high call volume, responding to calls as backup or handling some calls on their own, freeing up full-time resources.

This past year, Reserves trialed the use of a hybrid reserve peace officer training and certification program through the Iowa Law Enforcement Academy. The program consists of online training modules and exams supplemented by hands-on training and competency evaluations and has been met with positive feedback by reserve programs throughout the state. Successful completion of the 84 hour online classes, seven module exams, a comprehensive final exam, and practical and in-person exercises yields state certification, which is required within 18 months of hire. Reserves complete the same defensive tactics and firearms training as full-time staff.

The Johnson County Reserves will continue to build on 2023 successes through initiatives in the areas of training and engagement. The Unit is rewriting the patrol qualification program to more closely mirror that used for full-time patrol deputies, including the use of dedicated field training officers with the goal of providing consistent, high quality training. Reserve deputies are underutilized in other divisions at the Sheriff's Office, particularly the Jail. Reserve deputies hired after January 1, 2024 will spend a minimum of 40 hours shadowing Johnson County Jail staff before matriculating onto any other division of assignment within the Office, which will provide some basic training and in introductions to jail operations, allowing reserve deputies to be called upon as manpower resources in the Jail as they already are utilized in the Patrol Division.

Canine Echo

Echo is a Belgium Malinois born September 9, 2017 in Massachusetts for Canine Tactical of Iowa. He is a cloned canine, chosen for his high hunt drive and trainability. He is currently number 10 of 15, and five of the cloned canines are with law enforcement agencies in Iowa. Echo and his handler, Deputy Jesse Lenz, were trained in Chariton, Iowa by Canine Tactical of Iowa. Echo is trained in narcotics, tracking, building searches, article searches, apprehension, and officer protection. He started his career at 10 months old with the Johnson County Sheriff's Office in July of 2018.



Canine Bo

Bo is a Belgium Malinois born June 16, 2019, in Mexico. He and his handler, Deputy Kyle Campbell, were trained at Northern Michigan K9 and continue monthly trainings. Bo is trained in narcotics, tracking, building searches, apprehension and officer protection. He started his career at 15 months old with the Johnson County Sheriff's Office in July of 2020.



Canine Rudy

Rudy came to the Johnson County Sheriff's Office from a rescue organization in Des Moines, Iowa. He and his handler, Detective Alissa Schuerer, are nearing the completion of their therapy training. Rudy's primary goal is to support staff after traumatic incidents or job-related stressors and to be a resource for victims and witnesses. Rudy works a 42 hour week providing support and is a simple, non-confrontational resource to help build office morale, reduce cumulative stress on the job and improve emotional well-being. He accompanies Detective Schuerer during community outreach engagements on a regular basis.

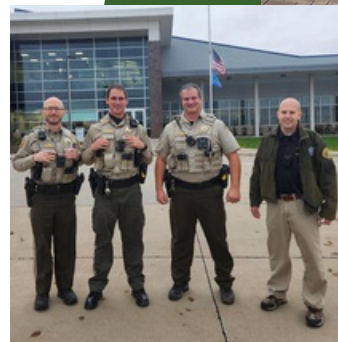

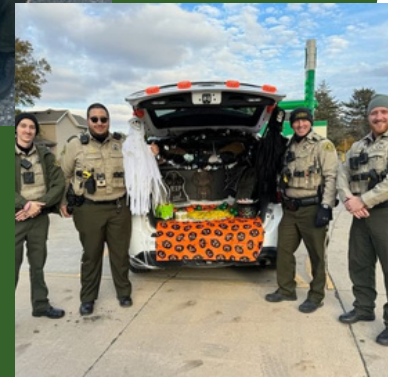
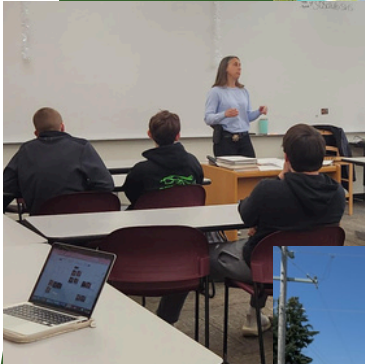
