6) Finances – Jacoby

- a) Finished FY21 with \$4,044 in expenditures; billed \$2520 fee for Webspecs on FY21
- b) Renewed domain name
- c) FY22 just began; no expenses yet; budget of \$5,000
 - a. Budget is less than previous year because no web support expenses or webhosting fees anymore because of new county website
 - b. Encourage Action teams to reach out to Policy Board for event materials, resources!!!
 - c. Community Foundation Account Balances charitable giving \$8,074 and endowment fund \$2,850
 - Haven't been used recently; previously used to support website expenses; some funds are designated for projects/activities
- d) FY23 Budgeting begins at the County level in October
- e) Each Action Team TO DO: determine expenditures at Sept Mtg; bring to Oct Board mtg
